The Dark & Stormy Night author series had a strong showing, with 17-20 attendees for each author talk. The most popular author was John Larison, author of the brand new Western *Whiskey When We're Dry*.

"Beyond Pronouns" and "LGBTQ 101," our two LGBT History Month programs, were very enjoyable and garnered attendance of 17 and 12, respectively. I would have loved to see a bigger crowd, but I was pleased by how enthusiastic those who did attend were. One woman who attended both talks left the following comment on Facebook:

### **Star Khan Awarded ALSC Equity Fellowship**

Outreach Coordinator Star Khan has been awarded the ALSC (Association of Library Service to Children -- a division of the American Library Association) Equity Fellowship. As a fellowship recipient, she will receive funding for two-year ALSC and ALA memberships and one year of conference registrations and travel stipends for ALA Midwinter and ALA Annual. She will also receive mentorship from members of the Equity, Diversity, and Inclusion within ALSC Task Force. Star was chosen for her demonstrated commitment to outreach to youth in the community and her potential as a library leader. Star has already demonstrated leadership here in Lincoln City and in the Oregon library community through her work with Libros for Oregon and REFORMA Oregon, organizations dedicated to bringing library service to Spanish-speaking and Latinx community members, as well as her work with Teena to increase outreach efforts to children in this community in Lincoln City.
